**The Incredible Years (IY) is a highly effective program that has been proven, through over 30 years of rigorous research, to improve the social and emotional health of children ages 3-8. IY works with children, their parents, and teachers to give each of them the skills necessary for children to arrive at school emotionally and socially ready to learn, and to succeed once they are there. IY produces significant reductions in conduct problems and significant increases in social skills at home and school. The program is made up of three distinct units that work together to achieve outstanding outcomes: Parenting education (strengthens positive parenting skills), Dinosaur school (skill building for children, taught in classrooms), and teacher education (teaches classroom management).**
